

### A MESSAGE FROM THE CHAIRMAN

### STRENGTHENING OUR BUSINESS COMMUNITIES

### **COMMUNITY ENGAGEMENT**



Naturally Lewis, in partnership with the Lewis County Chamber of Commerce, Jefferson County Economic Development, the Greater Watertown Chamber of Commerce and Jeff-Lewis Board of Realtors, hosted a virtual **North Country Real Estate Round Table** event in February. Our economic development partners and regional real estate experts discussed tools to attract and retain people to live and work in our region.



In partnership with the Lewis County Chamber of Commerce, we hosted our first hybrid, in-person and virtual, event **Breaking Barriers & Building Connections** for a successful summer season. Business owners and organizations in attendance discussed collaboration for future events in Lewis County.



In partnership with the Lewis County Planning Department and the Village of Lowville, assisted with the application for the **New York State Downtown Revitalization Initiative**. Naturally Lewis staff worked with several downtown businesses to explore and develop potential opportunities for grant funding.



### CREATING DIGITAL & E-COMMERCE SOLUTIONS FOR BUSINESSES

Naturally Lewis partnered with Coughlin in 2020 to launch the **mynny.biz platform** to to provide low-cost, high quality digital and e-commerce solutions for businesses. In 2021, we were able to increase small business presence online with a total of **20 small businesses websites.** 



### STRENGTHENING OUR BUSINESS COMMUNITIES





Naturally Lewis launched the **DBA Lewis County Program** to assist aspiring entrepreneurs and small business owners in Lewis County to launch and grow their businesses! By utilizing our local and regional economic development technical assistance partners and building a local network of consultants, we are able to connect entrepreneurs with services and resources to reach their goals. Although many services are free, DBA Lewis County is helping to alleviate some of the costs associated with other programs and services as an incentive to entrepreneurs working to launch and grow.

### WINTER DESIGN CHALLENGE

The LCDC was able to secure \$10,000 through the Pratt Northam Foundation and \$10,000 through Lewis County to create a **\$20,000 grant program** for winter based businesses during the 2020-2021 Winter Season. The grant program covered 50% of project costs, up to \$1,000, and asked hospitality, tourism and entertainment businesses and not-for-profits to submit proposals for creative indoor or outdoor dining solutions, creative service solutions or unique experiences.

### LEADING ECONOMIC DEVELOPMENT PARTNERSHIP

Lewis County Economic Development leads monthly economic development discussions with County partners including Lewis County (Management, Planning & Community Development Department, Parks & Recreation Department), Jefferson Community College, Snowbelt Housing Company, The WorkPlace, Cornell Cooperative Extension - Lewis County, & the Lewis County Chamber of Commerce. Conversations have led to collaborative projects and continued progress in the County.

### REGIONAL ECONOMIC DEVELOPMENT PARTNERSHIP

The Drum Country, New York, region encompasses Jefferson, Lewis and St. Lawrence counties in north-central New York state. This is a multi-sector **economic and workforce development partnership** created to help prospective Drum Country employer access the information, resources, and incentives needed to make our location their best asset.

In 2021, Drum Country, New York launched the **LET'S MEET marketing campaign** is to encourage business expansion in the region, draw new business and industry, and attract and retain a skilled and diverse workforce.



### **LEADERSHIP IN OUR COMMUNITY**

### CHILDCARE SOLUTIONS

In partnership with Lewis County Planning Department, the Community Action Planning Council (CAPC), Jefferson Community College (JCC), and the Small Business Development Center (SBDC), have developed an accelerated program to empower, educate, and launch new regulated in-home day care facilities in Lewis County. The **Regulated Home Day Care Training Bootcamp** will work to support the urgent demand for affordable, safe, high-quality childcare in Lewis County and the North Country while fostering entrepreneurship and the creation of 2 new childcare businesses in Lewis County and 10 in Jefferson County in the first year!









### SNOWMOBILE ECONOMIC IMPACT STUDY

Lewis County, in partnership with Tug Hill Regional Partners contracted with the Center for Community Studies at Jefferson Community College (JCC) and Camoin 310 to undertake an economic impact study of snowmobiling in Lewis County and the Tug Hill Region.



### **LYONSDALE PROPERTY**

The Lewis County IDA sold the former 46 acre ReEnergy Biomass Site in 2021 to Rezk "Rez" Abdelrahman for the **future development of a USDA Meat Processing Facility**. Staff contracted with Camoin310 to undergo a RFEI and RFP process and received 7 project proposals for the site.







### LYONS FALLS MILL PROPERTY

The Lewis County Development Corporation completed the last phase of **beautification of the former Lyons Falls Pulp and Paper Mill** after a decade of demolition, clean-up and six-million-dollars invested into revitalization of the property. As a result, the overgrown shrubs that blocked the view of the river and the original canal wall and the piles of industrial debris left behind by the decade-long cleanup process have all been removed, leaving an expanse of possibilities for the waterfront property. Staff is working with LCDC Board to market and sell the property.
