NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 859-a of the New York General Municipal Law will be held by the County of Lewis Industrial Development Agency (the "Agency") on the 25th day of June 2019 in connection with the following matter:

US Light Energy, a limited liability company(the "Company") has submitted an application to the Agency requesting that the Agency consider undertaking a project (the "Project") consisting of: (A) the installation, maintenance and operation of a solar array producing 5.0 megawatts AC of energy and transmission of such energy to an interconnection station; (B) the granting of certain financial assistance in the form of exemptions from real property taxes and sales tax (the "Financial Assistance"); and (C) the lease (or sub-lease) of the Land and the Facility by the Company (and/or the owner of the Land) to the Agency pursuant to a lease agreement; the acquisition by the Agency of an interest in the Equipment pursuant to a bill of sale from the Company; and the sublease of the Project Facility back to the Company (and/or the owner of the Land) pursuant to a sublease agreement.

The Company will be the operator of the Project Facility.

The Agency has not made a decision with respect to the undertaking of the Project or the granting of the Financial Assistance.


