NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing will be held by the County of Lewis Industrial Development Agency on December 2, 2021 at 8:30 AM, local time, at the Lewis County JCC Education Center, 7395 East Road, Lowville, New York. That hearing will relate to the following matter:

Port Leyden Portal, LLC (the "Company"), has submitted an application to the County of Lewis Industrial Development Agency (the "Agency") requesting that the Agency furnish the Company with financial assistance with regard to a commercial project (the "Project") contemplated by the Company. That Project would consist of the renovation of the former school building at 7320 East Main Street in the Village of Port Leyden, Town of Lyonsdale, Lewis County, for the purpose of operating an apartment complex for individuals 55 and older at that location (the "Facility").

An Environmental Assessment Form (EAF) has been submitted to the Agency by the Company regarding the Project. A copy of the EAF is available for review at the Agency offices at 7551 South State Street, Lowville, New York. Said EAF will be reviewed at a regular meeting of the Agency on December 2, 2021 at the time and place set forth above.
